1. The purpose of this memorandum is to provide information to Headquarters and Headquarters Squadron, MCAS New River regarding my requested administrative exemption from any COVID-19 vaccination per AR 40-562, Appendix C code AT "legal action pending, other than code AR".

2. Reference (b), paragraph 2-6a (1)(b) states, "General examples of medical exemptions include the following: Evidence of immunity based on serologic tests, documented infection, or similar circumstances." On the basis of documented infection, as exhibited by enclosure (1) and the serologic test by enclosure (2), I am requesting to be medically exempt from any COVID-19 vaccination due to reference (c).

3. Reference (b) is an all-service publication updated in 2013 that codified the Department of Defense's best medical understanding of how to implement vaccines, such as the current Emergency Use Authorized (EUA) Pfizer BioNTech (BNT-162b) injectable for the Total Force. The exemptions listed there reflect the well-established medical science regarding human virology and immunology. No person should receive a vaccine for a pathogen to which their immune system has already been exposed because of the following:

a. There are well-documented risks associated with introducing any biologic into the body, even ones that have a long safety record - which this novel mRNA injectable does not

because it has not even completed a single Phase 3 clinical trial.

b. Once the immune system has had a fully-encoded copy of a pathogen that has been introduced and defeated, the immune system is now prepared to attack that pathogen if and when it sees that pathogen again. This is why those who have had chickenpox as children, for example, are not recommended to get the chicken pox vaccine because there is a of introduction of that pathogen and might induce the immune system to attack the pathogen and cause harm to the person's body. There is only one immune system and vaccines do not provide anything "new" to the body once it has seen a virus "in the wild."

4. Additionally, I am part of the representative class of a civil action, reference (c), regarding the Secretary of Defense's directive, reference (a), to mandate COVID-19 vaccinations for service members. Court disposition of this civil action is pending.

5. Serving in the United States Marine Corps is the greatest honor of my life. I submit this memorandum with the utmost respect, and I have sworn to support and defend the constitution of the United States of America against all enemies foreign and domestic, as well as the health, safety, and lethality of the force.
